7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance with all statutory requirements like EPF, ESI, and Labour Laws, etc., with respect to the school and staff of the school.
9. That the school will ensure that Building Safety, Fire Safety, Water Safety, Health, and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per prescribed terms.

17. That State pattern classes IX to XII running prior to the affiliation to CBSE would be sponsored for the State Board Examinations. State pattern classes IX to XII will be closed in a phased manner. No admissions will be taken in State Board pattern Class IX to XII after getting affiliation from CBSE. The State Board School will be discontinued after switchover to CBSE.
